

However, the committee of assessors have noted it as 70.73% (i.e. 290 out of 410) at 10:00 am because 21 admitted IPD patients were attending radiology investigations and surgical operation theaters as followings</p> <p>12 IPD patients were being x-rayed, 5 IPD patients were in ultrasound section and 4 IPD patients in operation theaters. Details of the same is being attached as <i>(Annx - III)</i></p> <p>Details of all 311 IPD patients who were on bed at 10:00 am on 11.12.2018 is being attached as <i>(Annx - IV)</i></p> <p>It needs to be emphasized that this list of 311 IPD patients was also taken by the assessors on date of inspection and have been submitted to MCI. <b>For purpose of working out the deficiency:</b>
(1) The deficiency of teaching faculty and Resident Doctors shall be counted separately.
<b>(A) For Teaching Faculty:</b>
(a) For calculating the deficiency of faculty, Prof., Assoc Prof., Asst. Prof & Tutor in respective departments shall be counted together.
(b) Any excess teaching faculty in higher cadre can compensate the deficiency of lower cadre of the same department only.
(c) Any excess teaching faculty of lower cadre/ category in any department cannot compensate the deficiency of any teaching faculty in the higher cadre/category of the same department or any other department. e.g. excess of Assistant Professor cannot compensate the deficiency of Associate Professor or Professor.
(d) Excess/ Extra teaching faculty of any department cannot compensate the deficiency of any teaching faculty in any other department.
<b>(B) For Resident Doctors:</b>
(a) Excess of SR can be compensated to the deficiency of JR of the same department only.
(b) Excess SR/JR of any department cannot compensate the deficiency of SR/JR in any other department.
(c) Any excess of JR cannot compensate the deficiency of SR in same or any other department.
(d) Any excess/ extra teaching faculty of same or any other department cannot compensate the deficiency of SR/JR. e.g. excess of Assistant Professor cannot compensate the deficiency of SR or JR.
(2) A separate department of Dentistry/Dental faculty is not required where a dental college is available in same campus/city and run by the same management.
(3) Colleges running PG program require additional staff, beds & other requirements as per the PG Regulations - 2000.

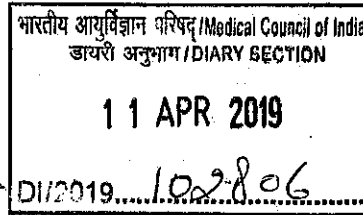

**Subject:- Compliance visit of MCI assessors on April 8, 2019 - regarding.**

Sir,

1. A team of two MCI assessors visited our college campus on 08<sup>th</sup> April, 2019 for compliance verification. In the assessment report dated 08<sup>th</sup> April 2019, the inspectors have wrongly reported the teaching faculty deficiency as 12.05% which is evidently incorrect. Assessors have reported that the following faculty members have presented them after 11:00 am. and it is reproduced from the assessor's report on page no. 14.

**It is emphasized that these above mentioned Faculty/Residents are working on regular basis and they were also present on 08<sup>th</sup> April, 2019 the day of assessment from 09:00 am onwards.**

In this context it is submitted that they were not counted by the assessors as out of the two assessors, one went on hospital rounds and only one was doing head counts. **As we are having 117 faculty and 66 residents, though all of them were present in queue for being counted.** They could not be counted as the **queue was very long and only one assessor was doing the counting.** Many of the faculty members and residents though waiting in the queue could not be counted as the **counting was stopped at 11:00 AM.** Many of faculty and residents waiting in the queue were left uncounted. **The documentary evidence in the form of Photos & video CD of their being present in the campus is being attached.**

**It is very important to mention that these faculty members were verified, accepted and counted during the last MCI inspection done on 11<sup>th</sup> & 12<sup>th</sup> Dec. 2018.** The Documentary evidence of their being verified, accepted and counted is being submitted in the form of relevant pages & summary of the assessor's report dated 11<sup>th</sup> & 12<sup>th</sup> Dec, 2018 is being attached. It is also emphasized that when the present team on 08<sup>th</sup> April 2019 accepted that the faculty and residents were present but were not counted in the report itself.

2. The Dean has commented on the same page of the report itself that the following Faculty/Residents residing in the campus and were physically present at 09:00 am onwards on 08<sup>th</sup> April, 2019 but they were not counted by the assessors

The Dean's comments were turned down and these above mentioned **8 Doctors were also not accepted** by assessors and these 8 Faculty/Residents were considered to be absent and were not counted though they were present.

Further, following **three Faculty members** present in the campus and were verified accepted and counted during last MCI assessment on 11<sup>th</sup> & 12<sup>th</sup> Dec., 2018 were not counted by the present team, though they were present in the campus from 09:00 am onwards on the day of assessment i.e. 08<sup>th</sup> April, 2019

Counting these faculty members & Resident Doctors who were present in the campus from 09:00 am onwards and were regularly employed and were verified, accepted and counted during the last MCI visit held in Dec, 11<sup>th</sup> & 12<sup>th</sup> 2018, would result in 0% deficiency in Faculty & Resident doctors.

It is humbly prayed that based on the above submissions resulting into 0% deficiency in compliance visit necessary permissions to take admission in the 4<sup>th</sup> batch of 150 MBBS students may kindly be granted to World College of Medical Sciences & Research, Gurawar, Jhajjar, Haryana.
