






1	Deficiency of Faculty 25 Nos. (18.93%)	<p>As per MSR the requirement for Faculty is 132 Nos. During the assessment, the College had 139 Faculty. Few faculty were not accepted by the assessors without any valid reason. On the day of assessment our actual faculty shortage was only 9 Nos. out of 132, i.e. 6% deficiency. We have recruited few faculty and current deficiency is only 6 Nos. out of 132, i.e. 4% deficiency which is within the accepted limits of MCI norms. The College is trying its best to close the existing vacancies. Detailed explanation is submitted below. The supporting documents are attached.</p> <p><b>Physiology Department (Deficiency of 1 Tutor)</b>  <b>Tutor</b>  Dr. Sai Sailesh Kumar was appointed as Assistant Professor, Physiology considering his experience as Assistant Professor since 1.9.2010 in other institutions which was also approved by MCI. He is already awarded PhD and is fully eligible to be considered as an Assistant Professor against the post of Tutor in the department.  <b>Hence there is no deficiency of tutor in Physiology Department and the deficiency is reduced to 24 Nos.</b></p> <p><b>Pharmacology Department (Deficiency of 1 Associate Professor &amp; 1 Tutor)</b>  <b>Associate Professor</b>  Dr. Revanna Swamy, Professor is appointed on 17/04/2018 and hence the deficiency of 1 Associate Professor is rectified.  <b>Tutor</b></p>	Deficiency of Faculty 02 Nos. 		<p>The deficiency of 1 Tutor was reported by the assessors citing that the joining report of Dr. Kaushik was that of Junior Resident instead of Tutor which was only a clerical error. Even though the College corrected the error and submitted to the assessors they did not accept the same. However, Dr. Kaushik subsequently resigned and is replaced by Dr. Ashiq Muhammed.  <b>Hence there is no deficiency of 1 Associate Professor &amp; 1 Tutor in Pharmacology Department and the deficiency is reduced to 22 Nos.</b></p> <p><b>Community Medicine Department (Deficiency of 1 Epidemiologist cum Assistant Professor &amp; 3 Tutors)</b>  <u>Epidemiologist cum Assistant Professor</u>  Dr. Nirmal (Epidemiologist cum Assistant Professor) was on field work as assigned by the community medicine department. He was called back for MCI verification, but he could reach the College only at 11.15 AM and he was not accepted by the assessors.  <u>Tutor</u>  Dr. Sakeer Hussain (Tutor), Dr. Sajmi C A (Tutor) and Dr. Fathima Thasleema (Tutor) were on field work along with Dr. Nirmal as assigned by the community medicine department. They were called back for MCI verification, but they could reach the College only at 11.15 AM and were not accepted by the assessors.  <b>Hence there is no deficiency of 1 Epidemiologist cum Assistant Professor &amp; 3 Tutors in Community Medicine Department and the deficiency is reduced to 18 Nos.</b></p> <p><b>General Medicine Department (Deficiency of 2 Associate Professors)</b>  <b>Deficiency of 2 Associate Professors exists and deficiency reported is accepted.</b></p> <p><b>Pediatrics Department (Deficiency of 1 Professor &amp; 1 Associate Professor)</b>  <u>Professor</u>  Dr. Venugopalan, Pediatrics has 4 publications and is eligible to be considered as Professor.  <u>Associate Professor</u>  Dr. George Jose has been promoted as Associate Professor, Pediatrics well before the cutoff date of 23<sup>rd</sup> July 2014 (publications were not required) and is already accepted as an Associate Professor during previous inspections.</p>

		<p>Hence there is no deficiency of 1 Professor &amp; 1 Associate Professor in Pediatrics Department and the deficiency is reduced to 16 Nos.</p> <p><b>Orthopedics Department (Deficiency of 1 Associate Professor)</b></p> <p><u>Associate Professor</u> Dr. Jyodish K S retired from Govt. Medical College, Calicut as Professor, Orthopedics and later he worked at Kannur Medical College where the relieving order was not issued. He has intimated the same to MCI and submitted an affidavit with intimation to our college. He was accepted as a Professor during the previous inspection. He misplaced the affidavit during the assessment and the same is produced now.</p> <p>Hence there is no deficiency of 1 Associate Professor in Orthopedics Department and the deficiency is reduced to 15 Nos.</p> <p><b>Oto-Rhino-Laryngology Department (Deficiency of 1 Associate Professor)</b></p> <p><u>Associate Professor</u> Dr. Viswanathan was promoted as Associate Professor, Oto-Rhino-Laryngology on 19/08/2013 which is well before the cutoff date of 23<sup>rd</sup> July 2014 (publications were not required) and was already accepted as an Associate Professor during previous inspections.</p> <p>Hence there is no deficiency of 1 Associate Professor in Oto-Rhino-Laryngology Department and the deficiency is reduced to 14 Nos.</p> <p><b>Ophthalmology Department (Deficiency of 1 Associate Professor &amp; 1 Assistant Professor)</b></p> <p><u>Associate Professor</u> Dr. Shrinivas M S, has 2 publication and is fully eligible to be considered as an Associate Professor and was accepted as an Associate Professor during the previous inspection at our institution itself.</p> <p><u>Assistant Professor</u> Prior to joining our institution, Dr. Kshama K K worked at Jawarharial Nehru Medical College, Belgaum as Assistant Professor, Ophthalmology for 3 years and 2 months. Hence the requirement for working as Senior Resident does not apply in her case as per MCI guidelines.</p>





2	OPD: On both days, at 09:40 a.m., most of the faculty & residents were not available.	On 14 <sup>th</sup> March 2018, all faculties and residents were called to mark attendance by one of the assessors at 9.45 am which continued till 11 am. Meanwhile another assessor visited the OP areas and hence the Faculty and Residents were not available. As the physical verification of faculty documents on the first day of assessment (14.3.2018) extended up to 7 pm in the evening, most of the faculty and residents could not complete their ward rounds on 14-03-2018. After seeing a few patients in the OPD before 8.30 am on 15 <sup>th</sup> March 2018, they went for their ward rounds and came back to their OPDs only by 10-10.30 am	Faculties & Residents were available at the time of Assessment.
3	Bed Occupancy at 10 a.m. on day of assessment was 61.69 %; however about 15 % of the patients were not genuine, reducing Bed Occupancy to 46 %. Out of these, most of the patients were admitted on a day prior to assessment.	The facts reported by the assessors is not factual. The assessors counted only those patients who were on the beds (as clearly mentioned in Page No. 13 of the assessment report) and did not take in to account the patients who went for investigations, procedures, OT (19 surgeries) and those who were in the washrooms, pantry, etc. On 14 <sup>th</sup> March the number of IP was 491 (bed occupancy of 75.5%) and on 15 <sup>th</sup> March the number of IP is 506 (bed occupancy of 78 %) (up to 2 pm on both days). The average IP in the previous month is more than 78%. The entire list of inpatients is attached.	Bed Occupancy at 10 a.m. on day of assessment was 83.1 %. On random checking the patients were found genuine.
4	<b>Patients</b> On verification of the patients on the beds (from among the 401), the following patients were notified in most of the wards, indicating the non-genuine patients. For example-	All the patients admitted were genuine and the observation of assessors is not factual. Detailed explanation is given below.	The authenticity of the patients mentioned in the report cannot be ascertained at present.
	1. Mini C K, WIMS No.258951, General Medicine 3 was admitted on 14.3.2018 at 9.40 pm, when we were inspecting the institute at 9.30 am on 14.3.2018. Nurses clinical chart was entered even for	Mini CK WIMS 258951, the patient had been in the hospital since 13/03/2018 evening, which is evident in the clinical chart vital recording and as mentioned by the assessors. The date and time entered looks like a clerical error from the admission counter. The assessors reached Deans' office only at 9.40 am on 14 <sup>th</sup> March 2018 after which only they went to the hospital for verification.



No case notes of the patient in the case sheet and no treatment (evidence case sheet attached – Xerox)	Raimanath WIMS NO 310182 came to Emergency department with Low back pain, Pelvic inflammatory Disease, on 13/03/2018 at 8 pm and after doctors initial assessment & pain management in emergency department patient was admitted on 14/03/2018 at 1.36 am. The assessment and treatment details administered at ED is available with the case record of Emergency Department. Full documentation of the case sheet for all admissions may not be possible during busy case management at ED especially for less severe cases. For such case sheets, completion of case record is done during next day morning rounds. As the MCI attendance was held in morning at 9.45 am on 14 <sup>th</sup> March, the rounds got delayed and hence the case file was not completed.	
3. Mr. Sivan WIMS No.212033-Gen Medicine-Only admission request form-Entire In-patient records including names blank (evidence case sheet attached-Xerox)	Mr.Sivan WIMS No 212033 GM came to Emergency department as a known case of COPD, Hypothyroidism, cololithiasis, on 13/03/2018 at 5.50 pm and after doctors initial assessment in emergency department patient was admitted. Since this was old patient and a known case, the diagnosis, investigation plan and the treatment advised was endorsed in the case sheet by the admitting doctor and the patient was kept in the ED till 9.50 am under observation of management of acute symptoms. Hence the inpatient record is not completely empty as stated by assessor. The assessment and treatment details administered at ED is available with the case record of Emergency Department. Full documentation of the case sheet for all admissions may not be possible during busy case management at ED. For such case sheets, completion of case record is done during next day morning rounds. As the MCI attendance was held in morning at 9.45 am on 14 <sup>th</sup> March, the rounds got delayed and hence the case file was not completed.



	gives a history of bleeding at all, but only pain abdomen. The same was endorsed by the resident in the ward on the case sheet. No investigations and treatment given (evidence case sheet attached-Xerox)	yet. She was a known case of hypothyroidism already on treatment. She was given symptomatic treatment. When the Assessor Mrs. Vimala, who is a non-Malayali questioned regarding her chief complaint, patient said "No bleeding right now". This answer was not well understood by the assessor. Even the history was not well elicited by the assessor. Suddenly she called the Junior Resident available in the ward, forced her to endorse 'No complaint of bleeding' while patient had history of bleeding during periods.	
	Taking this into account in the wards, around 15% of the patients were non-genuine, taking the effective bed occupancy to around 46%.  Also apart from this, in the wards more than 50% of the patients were admitted on 13.3.2018, the day before the assessment.	The statement that around 15% of the patients "were non-genuine" is not factual as our average bed occupancy for the last one-year ranges between 75-80% which can be very well verified from the Hospital Records.  Without verifying the data with Medical Records Department, the statement made by assessors that 50% patients admitted in the wards were admitted on 13 <sup>th</sup> March is irrelevant. The entire list of inpatients attached as Annexure 2 clearly show the date of admissions. The number of patients admitted on each days are mentioned below. 10 <sup>th</sup> March – 102, 11 <sup>th</sup> March – 36, 12 <sup>th</sup> March – 117, 13 <sup>th</sup> March – 142. As all the MCI assessments are surprise in nature, the statement that patients were admitted the day before assessment is nothing but an imagination of the assessors.	
5	Data of Radiological & Laboratory investigations given by the Institute include data of private patients & Superspecialities patients which is not permissible.	Being the only tertiary care level institution in the whole district, we provide Super specialty services. We have few private rooms in the hospital in which patients are admitted.	Data of Radiological & Laboratory investigations given by the Institute do not include data of private patients & Superspecialities patients.
6	Wards: There is no signage of Unit wise bed distribution. No faculty & Residents were available in wards during the round.	This is not factual. In each ward we have provided Unit wise bed distribution charts. Faculty and Residents promptly take ward rounds every day in the morning itself. On 14 <sup>th</sup> March 2018, all faculties and residents were called to mark attendance by one of the assessors at 9.45 am which continued till 11 am. Meanwhile another assessor visited the Ward areas and hence the Faculty and Residents were not available. Unit wise bed distribution written in the white board are placed in each wards.
